# Saskatchewan Youth Visual Arts Project

The major provincial project for MFS each year is the Saskatchewan Youth Visual Arts Project. And this year it has received 40 art submissions from high school students from around the province.

A committee of Krishan Kapila, David Katzman, Frank Armistead, Meenakshi Manocha and Gagan Deep Singh are organizing various aspects of this project.

Out of these submissions, a jury of expert artists will select 15 finalists. The top five will receive monetary awards from \$15 to \$125 each.

Judging by a team consisting of Anne Campbell, Elmer Brenner and Madhu Kumar will select the finalists on April 11.

# MFS applies for funding for Canada 150th Anniversary Project

A working group of Krishan Kapila and Gagan Deep Singh have been working in conjunction with Multi-Cultural Council of Saskatchewan to apply for funds for project to celebrate Canada's 150<sup>th</sup> anniversary.

MFS sought the support of MCoS because it is a charitable organization and eligible to apply for such funding.

The project will take the form of a video production that will be multi-cultural, multi-faith and multi-lingual. It will involve youth and children involved in a variety of languages and songs, concluding with prayers in their own traditions. MFS has invited Regina Multi-Faith Forum and Multi-Faith Saskatoon to participate in as well and support the project.

## **President reports to Board Meeting**

Moses Kanhai, President of Multi-Faith Saskatchewan, reported at the Board meeting March 23 that since attending NAIN Connect in Guadalajara, Mexico last year, he has reported to CLIFF in Fort Qu'Appelle and Regina Multi-Faith Forum. To date, he has not been able to arrange a meeting with Multi-Faith Saskatoon.

He also reported that April 12 is the Lieutenant Governor's Saskatchewan Prayer Breakfast and there will be a table as multi-faith friends at that gathering. Later this month, Moses also hopes to meet with Archbishop Don Bolen to discuss how we can collaborate in our multi-faith work.

## MFS applies for operational funding

Donna Nelson reported to the Board that financial information required to make an application for operational funding from SaskCulture was delayed significantly. However, we did finally receive it and the application was submitted on the deadline and we are awaiting a decision on our request.

10 days before year-end, the balance sheet indicates that we have \$4,336 in current assets. There is an accrued liability of \$750 for accounting fees from last year, but no invoice has been received and we were informed that there would be no fee.

Donna also provided a profit loss statement for both MFS and the Visual Arts Project. Near year end, we have an operating surplus of \$413.

With the help of Dr. Brenda Anderson of Luther College to ascertain NAIN grants received and disbursed, Luther College is now paid in full for NAIN grants owing. Once the semester is over, MFS and Luther College will meet to talk about how we might use the remaining proceeds from NAIN to enhance the work of multi-faith between the college and the community.

Donna recommended that MFS change banks to allow better reporting and to eliminate bank fees. Following a Board motion, this change from BMO to Conexus Credit Union was approved and is in process.

### Membership and Revenue Generation

A working group of Donna Nelson and David Katzman is continuing to look at ways of expanding our membership to other communities and individuals around the province. Also they are tasked with proposing ideas for increasing our revenue.

Suggestions in either of these areas are welcome and may be forwarded to Donna or David.

# Partnership with Luther College/Reconciliation and Racial Justice

A working group of Amr Henni and Russell Mitchell-Walker are continuing to have conversations with Luther College about collaborating on mutual programs and in working toward Racial Justice. Frank Armistead is looking into the racial justice component of this project.

### Multi-Faith News from Saskatoon

Colin Clay reports that the new Ahmadiyya mosque has been completed and is being used. The grand opening will be in the summer.

The International Day for the Elimination of Racism on March 21 had over 200 people in attendance with a good multi-faith representation. There was a multi-faith program in the evening with a welcome by the Mayor and attendance of almost 100, followed by a meal. Representatives of many faiths spoke at the event.

Baha'i New Year was observed in Saskatoon last Month and Multi-Faith Saskatoon was represented.

Colin reported on many other community events that Multi-Faith Saskatoon folk attended and had good representation.

Archbishop Bolen and Rabbi Claudio held a music event of Leonard Cohen that packed the Cathedral.

#### Sikh Day Parade in Regina

The public is invited to attend the Sikh Day parade on May 20. It will start at the Gurdwara and proceed to the Legislature and back to the Gurdwara for a program and a meal.

# MFS support for Spiritual and Religious Care

Multi-Faith Saskatchewan received the news with deep concern that the recent provincial budget has cut funding for spiritual care in the province's health regions. This came at a time when MFS had a working group examining how it can support spiritual care for people of all faiths and religions in hospitals, penitentiaries and other institutions.

At the annual meeting of MFS last fall, members heard a presentation from Dr. Simon Lasair of the Canadian Association for Spiritual Care, Saskatchewan Region. He appealed to MFS for support in addressing issues of confidentiality to enable non-medical professionals to support hospital patients.

The working group of Colin Clay, Donna Spratt, Gagan Deep Singh, and Mary Brubacher were tasked to propose ways for MFS to engage in the spiritual care process from an inter-faith perspective. This task has now become significantly complicated with the termination of provincial spiritual care funding in health regions.

The CASC Saskatchewan executive sent a letter concerning this decision to the premier, the finance minister, and the health minister, as well as the corresponding critics in the opposition.

CASC is also appealing to MFS members to write letters to the individual MLAs mentioned in the letter below, and to mobilize individual faith communities to make their concerns known as well.

Through its association with the Canadian Multi-Faith Federation, MFS will also be considering how it can observe SRCAW 2017: Spiritual & Religious Care Awareness Week, October 16-22, 2017, with the theme of Forgiveness in an Unforgiving World.

The task group will also look at how it can participate in this event in the current climate in Saskatchewan.

The Canadian Multi-Faith Federation's Spiritual and Religious Care Awareness Week offers an opportunity to recognize the value of religious services and spiritual care and to honour those who provide the care. A SRCAW Kit includes resources to help participants create awareness of the profession and to help celebrate this very special work.

Dear Mr. Wall, Mr. Doherty, and Mr. Reiter,

#### Re: Spiritual Care in Saskatchewan

We are writing on behalf of the Saskatchewan members of the Canadian Association for Spiritual Care (CASC). Many of our members were affected by the decision in last week's budget to eliminate all base provincial funding to spiritual care, sometimes mistakenly called pastoral care. For the sake of patient, resident, family, and systemic wellbeing we strongly urge you to reverse this decision.

In health care people experience many stresses and losses: a terminal diagnosis, a stillbirth, disintegration of mental health, the progressing dementia of a parent or spouse, the death of a spouse, parent, or child, or life endangering surgeries. All these experiences have spiritual dimensions. In a system that prides itself on holistic and patient centered care, spiritual care practitioners are the only professionals trained and equipped to care for the spirit. Moreover, scientific evidence increasingly shows that professional spiritual care in health care improves patient, resident, and family experiences, in addition to improving medical outcomes. ii By eliminating our services, patients, residents, and families will no longer receive the emotional and spiritual support they need. The system will then need to care for secondary stress related health concerns, simply because patients, residents, and family members did not receive adequate holistic care.

As spiritual care professionals, most CASC members have achieved at least a Masters level education, as well as multiple units of nationally regulated spiritual care training. This education and training uniquely prepares spiritual care professionals to care for the complex emotional and spiritual needs of all people. iii

Finally, Accreditation Canada has mandated that professional spiritual care be part of the circle of care provided by health care institutions in Canada. Because most of their work occurs in non-medical settings, community clergy are not an integral part of the medical team. By eliminating our services, your budget is endangering the accreditation of many health care facilities in Saskatchewan.

For the sake of client wellbeing and safety, for the sake of the system's wellbeing, and for the sake of overall fiscal responsibility, we strongly urge you to reverse this budgetary decision announced last week. Sincerely yours,
